About the Civic Literacy Test Option

Fall 2018 Timeline

Students may sit for the test at FSU's Testing Center on the following dates during the Fall 2018 semester:

- Aug. 20, 2018 – Sept. 14, 2018, which includes Seminole Sensation Week and the first three weeks in the semester.
- Sept. 19th, Sept. 21st
- Oct. 1st, Oct. 3rd, Oct. 5th, Oct. 15th, Oct. 17th, Oct. 19th, Oct. 29th, Oct. 31st
- Nov. 2nd, Nov. 14th, Nov. 16th, Nov. 19th, Nov. 26th, Nov. 28th, Nov. 30th

Note: *Any student unable to take the Florida Civic Literacy exam at the Testing Center on the FSU Tallahassee Campus should contact testing@campus.fsu.edu for additional testing options.*

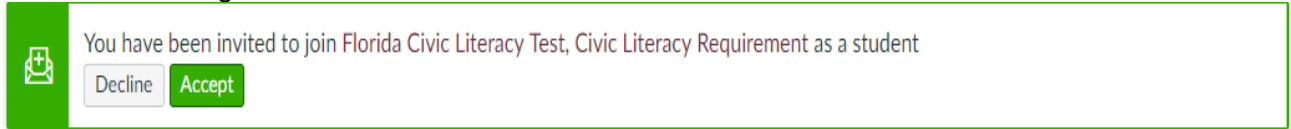
Test Registration

To register for the test students should visit <https://www.registerblast.com/fsu/Exam/List>. Select "Exams for FSU Students", then "FSU Civic Literacy", then "Florida Civic Literacy Test", then choose a date and time to sit for the test. See screenshots below:

You may take up to 2 hours to complete this test.

- No special materials will be allowed for the test (scratch paper, notes, etc.).
- You do not have to complete the questions in order, but be sure to answer all of them before submitting the test.
- Once you have submitted the test, you will see your final score. A score of 60 or higher is required to meet the Civic Literacy Requirement.
 - If your score is 50-59, you may retake the exam on the same day if time and space permit.
 - If your score is below 50, you should use the study materials available on the Canvas site to review and test again at a later date. There are no limits on the number of retakes to meet the Civic Literacy Requirement.
- Scores on this test will be maintained in Student Central and certification of meeting the Civic Literacy Requirement will be notated on your FSU transcript.
- **Before arriving for your test be sure to review the [Student Responsibilities for Students testing at the ODL Assessment and Testing facility](#) (items 3 – 11).**

Important Notes for Students

- 1) Once you pass the test, it will be noted on your transcript and in your Academic Requirement Report (ARR) that you have met the State of Florida's Civic Literacy Requirement.
- 2) Students will not be penalized for failing the test. Failing the test will not be reflected in your GPA or noted on your transcript.
